RELEASE AND WAIVER OR LIABILITY AND INDEMNITY AGREEMENT

Each applicant, as a registered guest of the Dirt Bikers Club of San Antonio, in consideration for the use of the land extended by the property owners individually, and for the applicant, their heirs, representatives, and assigns, for the use of the land currently leased in the future by the Dirt Bikers Club of San Antonio, in consideration of being able to operate a motorcycle or like vehicle for recreation, do hereby, as a member of the Dirt Bikers Club of San Antonio, individually, their heirs, representatives, assign agents or employees, acting officially or otherwise, release and indemnify from any and all claims, demands and causes of action on account of death, injury or theft to the applicant which may result from the use of said land by the applicant.

Each applicant hereby agrees to indemnify and save and hold harmless the property owners and Dirt Bikers Club of San Antonio from any loss, liability damage, or cost they may incur due to the presence of the applicant and in or upon said land whether caused by negligence of the property owners and/or the Dirt Bikers Club of San Antonio or otherwise.

Each applicant expressly acknowledges and agrees that the activity involved is dangerous and involves that risk of serious injury and/or death and/or property damage. Each applicant further expressly agrees that the foregoing release and waiver of liability is intended to be as broad and inclusive as permitted by Texas state law and that if any portion thereof is held invalid it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Each applicant has read and voluntarily signs that release and waiver of liability and indemnity agreement, and further agrees that no oral representatives, statements or inducements apart from the foregoing written agreement have been made.

Guest Policies

Please read the following information carefully, sign and return to the Sponsoring DBSA Member.

1. A "Guest Pass" will be valid for one day only. A day will consist of 1 hour before sunrise and 1 hour after sunset.
2. The DBSA sponsor will be responsible for their guests (riders and non-riders) at all times while on the property. Guests will not be permitted to ride at the property without their sponsor rider.
3. No chasing or tormenting the livestock or other animals on the property will be permitted. The landowner has cattle on Zars Ranch that DBSA shares this space with. Wildlife and cattle have the right of way.
4. Members are responsible for ensuring the gate is **LOCKED** upon **ENTRY** and **EXIT** of the property.
5. ALL members and guests are responsible for picking up and removing trash on the property. DBSA does not own Zars Ranch; we are only guests there. The owner of this property if this property insists that the property be kept trash free and will revoke the use of this property if this policy is not followed.
6. Members are responsible for all actions of themselves, their family members and guests.
7. The **ONLY** vehicles allowed in the riding area are **MOTORCYCLES, 3-WHEELERS, and QUADS**. (No pickups, bicycles, cars, dune buggies, etc.)
8. Members must have their membership card and key in their possession while on the property (cards and keys may be maintained on your person or in your vehicle). A member may be asked to produce these items while on the property. Refusal to comply may result in being asked to leave the property or being banned from the club.
9. Helmets must be worn at all times while operating any approved off-road vehicle on the property.
10. Slower riders **MUST** keep to the right of the trails to allow passing.
11. Trails marked with ribbon are one way only. Keep the ribbon to your right while riding them. Trails not marked by ribbon are by-directional. Ride with caution.
12. All pets must be on a leash at all times.
13. ALL current member rules will apply to all guests unless directly superseded by a directive on this form.

If a member or guest is found to be in violation of these guidelines, the board will be asked to review the issue. All decisions of the board are final.
